V. PRESENTATION AND RECEIPT FOR FILING OF THE 2021 FINANCIAL AUDIT CONDUCTED BY BELT HARRIS PECHACEK, LLLP – Robert Belt, Belt Harris Pechacek, LLP and Susan Grass, Finance Director

Robert Belt from Belt Harris Pechacek, LLLP was very pleased to report that the annual audit process has been completed and the City received an unmodified opinion which is the highest level of assurance a city can obtain. Mr. Belt shared the highlights of the Financials for 2021.

### VIII. MAYOR'S REPORT

A. CONSIDERATION AND POSSIBLE ACTION TO ADOPT ORDINANCE NO. 22-574, AN ORDINANCE OF THE CITY OF BUNKER HILL VILLAGE, TEXAS, EXTENDING A PUBLIC HEALTH EMERGENCY AND EXTENDING A STATE OF DISASTER DUE TO THE OUTBREAK OF COVID-19; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE

An Ordinance Declaring an Emergency was approved by the City Council on March 24, 2020 and later extended. The proposed ordinance includes an additional extension through April 2022 and ensures that any support needed from other agencies would be available to the City.

A motion was made by Councilmember Schwartz and seconded by Councilmember Brown to adopt Ordinance Number 22-574 to extend the Public Health Emergency and State of Disaster due to the outbreak of COVID-19.

It will be a very busy summer with the demolition of the old school, construction of various utilities, and reconstruction of the parking lot. The bridge and pedestrian path will be closed for the summer. The City and School will be sharing this information with the public.

- X. CONSIDERATION AND POSSIBLE ACTION TO APPROVE RESOLUTION NO. 04-19-2022 A, A RESOLUTION BY THE CITY OF BUNKER HILL VILLAGE, TEXAS SUSPENDING THE MAY 2, 2022 EFFECTIVE DATE OF THE PROPOSAL BY CENTERPOINT ENERGY RESOURCES CORP., D/B/A CENTERPOINT ENERGY ENTEX AND CENTERPOINT ENERGY TEXAS GAS HOUSTON DIVISION TO IMPLEMENT INTERIM GRIP RATE ADJUSTMENTS FOR GAS UTILITY INVESTMENT IN 2021 AND REQUIRING DELIVERY OF THIS RESOLUTION TO THE COMPANY AND LEGAL COUNSEL Karen Glynn, City Administrator

The City has received two requests from CenterPoint regarding increasing utility rates. One is for CenterPoint Gas and the other for CenterPoint Electric. The City, along with approximately 40 other cities served by CenterPoint ("CenterPoint" or "Company") is a member of the Gulf Coast Coalition of Cities ("GCCC"). The coalition has been in existence since the early 1990s. GCCC has been the primary public interest advocate before the Public Utility Commission, the Courts, and the Legislature on utility regulation matters for over 20 years.

The legal counsel for the GCCC recommended all cities take action on the resolutions:

### CenterPoint Gas:

CenterPoint Gas made Interim Rate Adjustment or "GRIP" filings with the cities in their Houston and Texas Coast divisions. For cities in the Houston Division, the Company is seeking recovery of \$193,152,387 in invested capital. This compares to \$153,689,801 last

year, \$157,664,708 in 2020, \$99,461,495 in 2019 and \$112,238,512 in 2018. Increases in the Houston Division are scheduled to go into effect on May 2, 2022.

Under the GRIP statute, cities may not challenge the Company's request. The only action cities may take is to suspend the effective date of the rate increase by 45 days.

# CenterPoint Electric:

CenterPoint filed an Application for Approval to Amend its Distribution Cost Recovery Factor ("DCRF") Pursuant to 16 Tex. Admin. Code § 25.243 to Increase Distribution Rates with each of the cities in their service area. The Company is proposing an adjustment to include additional distribution invested capital placed in service from January 1, 2019 to December 31, 2021. As a result of that adjustment, the Company is proposing a Total DCRF Revenue Requirement of \$198,422,017 to be effective on September 1, 2022. The resulting Total DCRF Revenue Requirement sought by the Company constitutes a \$145,680,810 increase to the currently approved total distribution revenue requirement that is scheduled to go into effect on September 1, 2022. The proposed Resolution would oppose the increase giving CenterPoint 30 days to appeal the decision to the Public Utility Commission where the appeal will be consolidated with CenterPoint's filing for the environs and those cities that have relinquished their original jurisdiction currently pending at the Commission.

A motion was made by Councilmember Thode and seconded by Councilmember Brown to approve Resolutions Nos. 04-19-2022 A and 04-19-2022 A B.

The motion carried 4-0.

XII. CONSIDERATION AND POSSIBLE ACTION TO AUTHORIZE CHANGE ORDER NO. 2 TO THE CURRENT CONTRACT WITH METRO CITY, LLC FOR THE RECONSTRUCTION OF CHAPEL BELLE RESULTING IN A NET DECREASE OF \$5,176.61 - Steve Smith, Director of Public Works/ Building Official

The construction contract with Metro City, LLC for the Reconstruction of Chapel Belle was approved in January 2022 and the project is proceeding very well. Change Order No. 2 was submitted for Council approval which is a net decrease to the contract in the amount of \$5,176.61. This change was the result of a required field modification to one of the stormwater inlets. The plans originally specified a concrete precast inlet, and this was changed to a field constructed inlet. The savings will be credited to the contingency fund for the project.

A motion was made by Councilmember Brown and seconded by Councilmember Schwartz to approve Change Order No. 2 to the contract with Metro City, LLC for the Reconstruction of Chapel Belle resulting in a net decrease of \$5,176.61.

The motion carried 4 - 0.
